


MINUTES TRURO BOARD OF ASSESSORS VIA VIRTUAL MEETING THURSDAY November 7, 2023, 3:00pm

The meeting was called to order by Mr. Gaechter at 3:05pm

Review/Approve Minutes:

FY24 Payment In Lieu of Taxes (PILOT) Provincetown Commitment

Motion was made by Mr. Gaechter to approve **FY24 PILOT Tax Commitment** in amount of **\$27,517.41.** Ms Townsend second the motion and all voted in favor.

FY24 Senior Work Off Real Estate Abatements

Motion was made by Mr. Gaechter to approve **FY24 Real Estate Tax Commitment** in amount of **\$12,254.69**. Ms Townsend second the motion and both voted in favor (recusal by A. Ditacchio).
