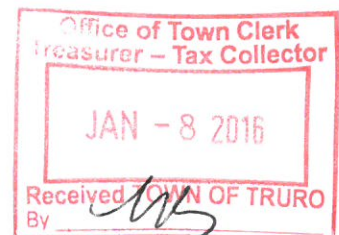

The meeting commenced at 6:00 p.m. with a quorum and covered the following agenda:

1. **Meeting minutes** of the September 8, 2015 meeting were approved.
2. **Public comments:** None.
3. **Outer Cape Bike and Pedestrian Master Plan:** The master planning committee met on Sep 23. The Cape Cod National Seashore reported that the route through the seashore is considered a sensitive area. All the routes recommended by Wellfleet enter Truro at Route 6. The next master planning committee is Oct 15, and a public meeting in Provincetown will be scheduled for early Nov. Jay Norton, Truro DPW, will be the new Truro representative on the master planning committee. The Cape Cod Commission map depicting the route through Truro as recommended by BWW requires correction. Once those have been made the map along with the recommendation letter will be posted to the Town web site.
4. **Mass DOT letter for Route 6 bike lane markings:** MassDOT informed the Town that work for the recommended bike lane along Route 6 will be performed in the spring of 2016, although they stated that there was inadequate space for rumble strips. The scheduling of a follow-up meeting with MassDOT and the Town was discussed.
5. **Road condition survey:** Tabled
6. **Brochure status:** 1000 copies have been received and will be distributed. The recreation department will be contacted regarding distribution at beach locations for next summer.
7. **Bike safety package purchase order:** Tabled
8. **Bike rodeo:** Tabled
9. **Budget:** The committee will submit a request for \$2,000 (same as FY 2016).
10. **Next meeting** is scheduled for Wed. Nov. 4, 2015 at 6:00 p.m. at the Truro Public Safety Facility.
