Chair Boyle called the meeting to order at 4:15 PM and invited the public to call in, providing the necessary information to do so.

 - · Chair Boyle asked if there were any corrections to the minutes. Being none, the minutes from April 27, 2022 were unanimously approved.
- 2. Agenda Item Scheduling Public Hearing for input to FY23 calendar
 - The CRC public hearing was scheduled to take place as part of the next Charter Review Committee meeting. It will be held on June 23, 2022 at 4:15PM with a break for a public hearing at 5:00PM.

- 3. Agenda Item Elect vs. Appoint Project Board of Health
 - There was a discussion of possible components to incorporate in the study including:
 - Contacting petitioners and inviting them to a CRC meeting in July
 - Inviting Board of Health members to a CRC meeting in July
 - o Developing questions CRC members may have and how to get them answered so How the BOH is handling work they took over from the WRC

 - The official charge for the BOH
 - How the BOH enforces regulations
 - Mr. Panessiti answered some of the questions raised.

- · Ms. Medoff asked about the ZBA and if we could get a final opinion on whether it must be appointed or can be elected.
 - o Action Item: Ms. Best will circulate the Town Council opinion on the topic of committees that can be elected or appointed.
- Mr. Panessiti cautioned about the importance of sourcing data, and shared the unusual case of Tisbury's Planning Board as an example of a multimember body that is both elected and appointed.
