Chair Boyle called the meeting to order at 4:15 PM and invited the public to call in and provided the necessary information to do so.

Agenda Item – Approval of minutes from the Charter Review Committee meeting from Thursday, June 23, 2022

Chair Boyle asked if there were any amendments to the minutes. Having none, a roll-call vote was taken to approve the minutes as written. Bob Panessiti did not attend the meeting on June 23, 2022 and did not vote on the minutes.

Agenda Item - ATM 2022 Article 36 - Charter Amendment to Section 2-3-3

- The Article regarding 20 petitioners and a lead petitioner according to the previous Select Board meeting was kicked back by the Massachusetts Attorney General in its current form. Discussion around the amendment and adjustments to make the amendment acceptable to the AG.
- Chair Boyle discussed sending it back to the Massachusetts Attorney General for review after edits and to be bundled with other legal matters at year-end and reviewed by the Select Board.

Agenda Item - Result of Recent Public Hearing

- Chair Boyle explained that two Public Hearings took place in 2022.
 - 1. Public Hearing # 1 took place on April 27, 2022.
 - 2. A second public hearing took place on June 23, 2022 to solicit public input on possible areas for consideration for warrant changes for the next year cycle. Committee discussion around the items raised at the June 23, 2022 hearing.
- Mr. Panessiti suggested the Charter Review Committee could educate town residents regarding
 how a town meeting form of government operates. Vice-Chair Medoff supports the need to
 educate the public on what role and charge of the Charter Review Committee is.
- Budgeting should be included, along with relevant procedures and protocols.

- Chair Boyle explained that the BOH elect vs appoint project is a citizens petition to change the Board of Health from appointed to elected. It is a continuing project.
