### Meeting Minutes of August 19, 2015 Truro Public Library: Cobb Room

**CERTIFICATIONS:** All the Trustee certification paperwork has been completed.

FOTL: Martha reported that the Book and Bake Sale took in approximately \$2000, a decrease of around \$900 over last year, but was successful in signing up 5 new FOTL members and renewing lapsed memberships. The timing of the event, which coincided with the Pan Mass Challenge may have contributed to the drop in attendance.

FOTL executive committee meeting representatives: Sept. 2 – Jack, Oct 7 - Barbara, Nov 4 -Jim, Dec 2 - Keith, Jan 6 - Sally

FIRE DOORS: Trish got an estimate of \$2500 to upgrade the two sets of fire doors so that they would automatically connect to the Library Fire Alarm system. She will also obtain an estimate for an upgrade to glass panel doors. She asked the trustees to make a note of other potential capital expenses for the coming budget cycle.

LIBRARY DIRECTOR'S REPORT: (Attached) Trish asked the Trustees for feedback about the type of data and organizational format that would be most interesting and helpful for her report. Barbara and Sally recommended longitudinal data charts or graphs to highlight trends.

Jack suggested that Trish explore the possibility of selling the unused Vault door.

STRATEGIC PLANNING MISSION STATEMENT: A second draft of mission statements offered by individual trustees was discussed. Trustees agreed to submit a next draft with attention to use of wording that includes 1) free and equal, 2) knowledge and learning, 3) creativity, 4) community and also can include a Belief Statement.
