#### DPW

- DPW Cabral had preliminary talks with Charge Point regarding installation of a two-port car charging station to be located at Town Hall. We expect a proposal early next week for purchase and installation.

- Effective Monday, January 25<sup>th</sup> at 5:00 AM, Governor Baker's "Stay at Home Advisory" for the hours between 10pm 5am is rescinded.
- The Mandatory Early Closure of Businesses Order requiring certain businesses to close by 9:30 PM will be also be rescinded, as of Monday, January 25<sup>th</sup>. Mark Peters and Peter Van Stratum left the Board in December, and we appreciate the opportunity that this report provides to express our gratitude to each of them for their years of service to the Town. Each brought unique perspectives and experience to the process and deliberations of the Board.
- Vaccination planning is in high gear as we anticipate standing up clinics on the Outer Cape possibly for
  phase 2 populations. We will work under the Barnstable County Health Department and are meeting
  together frequently to advance the initial site selection process. We will continue to provide updates on
  the process as the enormous task of vaccinating gets underway in large scale.
