
Announcements:





Department News:

DPW

- The Transfer Station will be closed every Wednesday and Thursday, November 1, 2020 through April 30, 2021.
- The Re-opening of the Swap Shop is currently under review with the Health Agent and DPW Director.
- DPW staff repaired the beach landing at Great Hollow Beach this week. Repair and maintenance consisted of transplanting beach grass, removing/replacing fencing, and re-installing all existing benches. In addition, another 5' entrance/exit was added to facilitate social distancing.
- DPW Director Cabral met with the Division of Ecological Restoration and the USDA to establish a scope of work for the Mill Pond culvert initial engineering services.
- DPW Director Cabral attended a kickoff meeting with GHD Engineering Services to review the scope of work to develop a long-term pavement management plan. Our goal will be to establish a 10-year plan with annual updates to the plan.





March 26, 2021

• A tentative schedule for installation and site work for the Cloverleaf watermain has been established. Work will begin April 5, 2021 for installation of the turtle protection fencing on the Cloverleaf site. Watermain installation on Highland Rd. is tentatively scheduled to be completed May 7, 2021.

Harbor Master/Shellfish Constable

- Shellfish Constable Jackett started preparing for the oyster remote set at the Dennis Transfer Facility
 where shell stock and supplies are stored. Annually around this time of year, shell bags are assembled
 and spread onto pallets. There will be 125 bags that will be trucked to the Aquaculture Resource
 Corporation Hatchery when they are ready to be deployed into their tank. Water temperature is
 manipulated to induce adult oysters to spawn. The spat will seek the substrate and attach to the shells
 secured into the bags.
- Harbor Master Jackett is entering information from application renewals for the upcoming boating season into the online system, as some of the information is incomplete or incorrect.
- Springtime temperatures brought out some 80 or so shellfish harvesters over the weekend. The increasing turnout has added pressure on the resource. We are closing the shellfish area for harvesting quahogs and oysters at the end of the month. We will allow the harvesting of soft-shell clams until April 11.

- The Truro Beach Office (36 Shore Rd) is closed and unstaffed and beaches are no longer protected by lifeguards. Currently beach stickers are not required to visit Town of Truro beaches or park in Town of Truro beach parking lots. ORV stickers are still required to access the bayside, off-road corridor. - **Puma Park Playground** is open. New tire swing and repairs were made by DPW. We remind the public to practice social distancing and wear a face mask in public. The playground is cleaned weekly and hand sanitizing stations are present. Portable restrooms will be available starting April 17th.

Health/Conservation

- Working with Outer Cape Health Services (OCHS), Truro completed delivery of COVID-19 Vaccinations to our homebound population at the end of last week. These residents were administered the J&J single-dose vaccine on Friday. They will be considered fully vaccinated next Friday after the 2-week period has passed. This effort was the result of collaboration between Town staff and OCHS; the list and appointments completed by the CoA, the vaccine administered by an Outer Cape Health nurse, and vaccine support provided by the Truro Fire Department. Excellent teamwork!
- The Outer Cape Regional Vaccination site at Little Creek in Eastham will continue to operate as the sole Outer Cape regional clinic. The primary focus for clinics on Cape will continue to be at the 4C's gymnasium. There is discussion about a <u>possible</u> walk-in clinic in Truro or Provincetown when vaccine doses increase, but the County has re-evaluated the scenario for a drive-through clinic at Pilgrim Springs. They have determined it is no longer a likely site for the future; this is largely due to the site being open to the public. The lack of a gate to close the site makes it not suitable for overnight and multi-day secure storage of the generator/dumpster/portable buildings/portable toilets, and that makes this a "set-up/breakdown" site. At this site, a clinic day would begin early with the mobilization of all of the required operational pieces, and at the end of the day will require a complete breakdown and demobilization of all equipment taken off site. Compare this to the Little Creek site, which is closed to the public, a feature that supports secure storage on-site of all the components needed for the clinic. Setup is basically turn-key, and the layout of the site allows a large throughput of participants.
- Vaccine eligibility expanded March 22, to include <u>certain workers</u> including restaurant and café workers, meat packing, beverage, agriculture, consumer goods, retail, or food service workers; grocery and convenience store workers, and food pantry workers/volunteers.
- The Cape Cod Regional Vaccine Consortium has expanded its focus to include these certain workers, and Barnstable County Health has developed a survey to identify the individuals eligible within this group. The survey will be issued to their employers, using our licensing lists and ultimately, once they take the survey, their employees will be able to schedule an appointment for the vaccine.
- The Board of Health has scheduled a Public Hearing for their April 6 meeting to review and approve proposed amendments to sections of local Board of Health regulations regarding fees, title 5 and private wells. Due to a compressed meeting schedule, the final review of these regulations will be held on April 6, and the public hearing moved forward to April 20.

March 26, 2021

Assessing

The Deadline for Exemptions for FY21 is **THIS** Thursday April 1, 2021 @ 4pm! This includes all Residential (Truro is your Primary Domicile as of January 1, 2020) and Statutory Exemptions (Seniors meeting strict Income and Asset guidelines, Disabled Veterans, and the Blind) as of July 1, 2020. If we do not receive your application by April 1st, by statute we cannot extend the deadline for any reason and we will be forced to deny.

- As a reminder-if you have already been approved for the Residential Exemption you do not have to reapply annually. The Assessor's Office will notify you if clarification is needed. Statutory Exemptions must reapply annually regardless of the situation.
