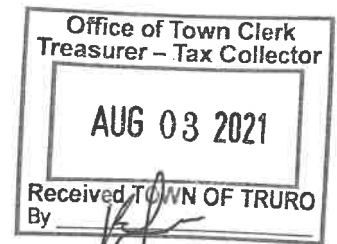




**MINUTES

The meeting was called to order by Mr. Boleyn at 12:00pm

Review/Approve Minutes:

Motion was made by Mr. Boleyn to approve the meeting minutes as written of the **February 2, 2021 meeting**. Motion was seconded by Mr. Forgione, All voted in favor.

Discussion of Board of Assessors Membership:

Discussion of the potential vacancy on the Board of Assessors due to Board of Assessors member Mr. Palmer not in attendance since March 2020 and the replacement process. This will ensure a smooth transition into Fiscal Year 2022.

Boat Excise Abatements:

Motion was made by Mr. Boleyn to approve **Boat April 2021 Abatements** in amount of **\$51.70**. Mr. Forgione second the motion and all voted in favor.

County Tax Forms:

Motion was made by Mr. Boleyn to approve **Fiscal Year 2022 County Tax forms to the Barnstable County Treasurer** in amount of **\$92,030.00**. Mr. Forgione second the motion and all voted in favor.

Motion was made by Mr. Boleyn to approve **Fiscal Year 2022 Environmental Protection Fund Tax to the Barnstable County Treasurer** in amount of **\$98,669.00**. Mr. Forgione second the motion and all voted in favor.

Executive Session:

Upon a motion by Mr. Boleyn that the Board of Assessors enter into EXECUTIVE SESSION under G.L.c.30A Section 21(a) (7), to comply with G.L. c. 59 Section 60 and G.L. 214 Section 1B to review abatement and exemption applications and not to resume an open session. Seconded by Mr. Forgione, the Board entered Executive Session to discuss exemption applications, roll call was taken, so voted. Session began at 12:15pm.
