Ms. Pajaron reported on current upgrades:

- 1.) 11 Hughes Rd. septic has been installed, pump & pump chamber just need to be inspected.
- 2.) 25 Meetinghouse Rd. should be started this week.

Bathing Beach sampling for June went well, no exceedances.

#### **PUBLIC HEARINGS**

1. Phillip Scholl, Change of Manager, East Harbor Motel & Cottages, 618 Shore Rd

No one was present.

2. John Petraborg, Peter & Philippa Vaughn, Board of Health Determination, Septic System Inspection Report for 390 Shore Rd (continued from 6/17/2015)

John Schnaible approached the Board and stated that he did the septic inspection report for this property. Everything was fine with the inspection but there was no design plan on record. It has all the elements and conforms with a 1978 system but under local regulations it is non-conforming. Ms. Rose & Mr. Peters expressed their concern with the situation since it is on Beach Point. Assessor's card has the property as a three bedroom home.

Mr. Peters motioned to deny the request and require the upgrade of the septic system.

3. Bernard Matrango, White Caps Cottages, 127 Shore Rd., Update on Cottage 5, Extend Temporary Motel License or Issue Permanent Motel License (continued from 6/17/2015)

Mr. Matrango could not be present. Ms. Pajaron reported that the applicant is still working on Cottage 5 and expressed that the applicant would like to request an extension to the temporary license until August 4<sup>th</sup>.

Mr. Peters motioned to approve the request to continue the hearing and extend the temporary license to their August 4<sup>th</sup> meeting.

4. Richard and Laurie Lee, Request for Title 5 Variance, 15.211, Minimum Setback Distances, 28 Fishermans Rd

Chet Lay represented the applicants. He stated they were requesting a 3" variance. Ms. Pajaron questioned elevations/flow barrier and recommends approving the variance with the condition that the septic be inspected prior to issuance of building permit. She also questioned the floor plan which shows an alcove with a 3' opening. The Board requires a minimum 5' opening.

Mr. Peters motioned to approve the variance with the stipulation that the septic system needs to be inspected prior to issuance of a building permit, that the alcove shall be changed to a 5' opening, and that a flow barrier shall be installed if the SAS is installed above the floor elevation of the proposed foundation.

Mr. Silva seconded.

Vote: 3-0-0, motion carries.

Continued Item #1: Phillip Scholl, Change of Manager, East Harbor Motel & Cottages, 618Shore Rd

No one was present.

Mr. Peters motioned to have Ms. Pajaron remind him to come to the next meeting, continuing the hearing to July 21, 2015.
