Ms. Rose brought up amending the regulations to incorporate the use of Innovative Alternative (I/A) systems for purposes of nitrogen reduction or in cases where the property owner wanted to use green technology such as an I/A System and not limiting these systems just in remedial cases. Chair Rose suggested that it's a change the Board should think about.
