Mr. Van Stratum brought up liability of the Transfer Station along with day-to-day operations of the Transfer Station and what decisions are made by the Board of Health and what ones are made by the DPW Director & Town Manager.

Ms. Beebe wanted to clarify the name document that Barnstable County Tobacco Control wanted the Truro Board of Health to sign. She previously stated that it was a grant, but corrected that statement and said it was a Participating Municipality Agreement and that it will have to be renewed periodically. She continued on and read the agreement. Ms. Rose, Mr. Silva, and Mr. Van Stratum all supported the agreement.
