

Truro Board of Selectmen  
Meeting Minutes – October 1, 2013  
Truro Town Hall, 8:30am

Chair Jay Coburn called the meeting to order at 8:30a.m.

**Review and Authorize the Chair to sign a Mass Department of Energy Resources Owner's Agent Technical Assistance Grant Application**

Assistant Town Administrator Charleen Greenhalgh explained that it could be a \$12,500.00<sup>1</sup> gain in grant money for the Town of Truro. Coburn asked for a motion. **Dunigan moved to approve the Massachusetts Department of Energy's Owner's Agent Technical Assistance grant application and authorize the Chair to sign. Weinstein seconded the motion. So voted unanimously 4-0.**

**Review and approve letter and or Resolution regarding NSTAR spraying**

Coburn asked Board members if they had additional corrections for the letter<sup>2</sup>. Weinstein added that he had a few corrections that he would like made in the letter and cited them accordingly. Wisotzky noted a couple of corrections that he had and cited them accordingly. **Dunigan moved to approve the letter as amended. Wisotzky seconded the motion. So voted unanimously 4-0.**

**Police Department Appointment**

Chief Kyle Takakjian, spoke of Officer Scott Holway's career history with the Coast Guard, and with the Truro Police department since 2006. He mentioned Officer Holway had gone through the process to test for potential Sergeants. Chief Takakjian stated that he was requesting their approval to appoint Officer Holway as Sergeant for the Truro Police department. **Dunigan moved to approve the appointment of Scott Holway as Sergeant for a probationary period of one year. Wisotzky seconded the motion. So voted unanimously 4-0.**

**Dunigan moved to adjourn. Wisotzky seconded the motion. So voted unanimously 4-0.
