### **TRANSIENT RENTAL MOORING AND FLOAT USE PROGRAM**

The following plan was designed to allow an individual to use a mooring or float on a short-term basis when they are unoccupied by the mooring or float holder. Any person wishing to use a mooring or float must follow the rules listed below and **MUST HAVE PERMISSION FROM THE HARBOR MASTER PRIOR** to using a mooring or float.

1. All mooring or float holders must still comply with the Pamet Harbor rules and regulations including the thirty-day annual rule, unless waived by the Harbor Master.
  2. All mooring or float holders will provide the Harbor Master with the dates the mooring is expected to be used.
  3. The Harbor Master will place people on a mooring or float based on the based-on availability.
  4. The rules regarding subleasing of floats or moorings will be strictly enforced. Any violations of any of the rules may be considered as grounds for removal from the mooring field and/or wait list.
  5. Use of moorings or floats may be limited to thirty days continuous use.
  6. Transient mooring users must sign the attached conditions of use form and must vacate the mooring immediately upon request of the Harbor Master and/or the float or mooring holder.
  7. Mooring or float holders are requested to give at least three day's notice to people who must vacate the mooring or float.
  8. Each **mooring or float user** is responsible for maintaining a secure mooring, lines, and ground tackle at all times and is responsible for any damage or injury caused by his or her vessel.

#### **TRANSIENT MOORING CONDITIONS OF USE FORM**
