Minutes of the Truro Housing Authority (THA) Thursday, February 02, 2017

N.B. MA state Open Meeting Law limits discussion of an issue not on the agenda to consideration of whether the issue should be placed on a future agenda.

The item numbers below refer to item numbers in the meeting agenda distributed electronically by Mr. Brotman on January 27, 2017 (copy attached).

#### 1) minutes of previous minutes

The minutes from the prior meeting on January 12, 2017 were presented and reviewed, but tabled pending the presence of the quorum of members who had been at that meeting.

## 2) review the current Truro Affordable Housing Trust, and consider updating the Trust in light of Massachusetts General Law Chapter 44 Section 55C

There was substantial discussion of the Law, and what possible things might be considered for inclusion in an updated Trust document. Examples might include governance, accepting land gifts, bonding, etc. It was agreed that Ms. Zola will develop a simple one-page list of possible Trust activities from the Law, and (a) which ones we do now with the THA, (b) which ones we do now with the current Trust, and (c) what we might be able to do with an updated Trust. Ms. Palmer said she would explore the tax deductibility of gifts to the Trust. Ms. Zola is to schedule some phone calls, and prepare materials for consideration for the Town Meeting on Tuesday, April 25, 2017.

3) update on Cloverleaf DoT land (NE corner of Route 6 and Highland Road)
The MA DoT is in the process of subdividing the land, using the state process for such activities. It is hoped this will be completed by February.

4) update on 143 Route 6 Habitat For Humanity (H4H) project (by Edgewood Farm) The lot preparation is underway. Ms. Zola said that from H4H's point of view it is going very well. The application process for possible home purchasing is underway; there will be one 1-bedroom, one 2-bedroom, and one 3-bedroom. The application deadline is March 21, 2017, with a number of information sessions in Truro and Yarmouth Port, through March 10, 2017. Mr. Brotman will present the program to the Selectmen on Tuesday, February 14.

5) review of strategies to consolidate our Housing Plan documents Due to time constraints, this subject was deferred to a later meeting.
