4. Administrator's Reports

4.1 Superintendent's Report: Mr. Gradone reported TCS did not get the Green Communities grant to convert the boilers to propane. Mr. Gradone met with Town Hall to move ahead to convert to gas with financial support from Cape Light Compact and Town of Truro. A green funding law was signed by Governor Baker July 30, 2018, so there's a possibility there will be increased support from the State. Administration has been brought up to date on TCS solar panel history. We now know how to take monthly readings and track the data. Mr. Gradone reported on the '18 end year balance, including the Cafeteria Revolving Account.

4.2 Principal's Report: Mr. Beaudet reported 6th grade currently has five students enrolled. The 6th grade team will infuse social justice in to literature, art and culture. The team is exploring options of a class trip to Puerto Rico during the '18 - '19 school year. Eliza Harned has been updating TCS databases to decrease our carbon imprint.

4.3 Director of Special Education Report: Mrs. Costigan reported there are two Special Ed. positions to fill. The extended year program is going well with two students out in the community, one student at Truro Vineyards and one student at Hillside Farms.
