- 1. Call to Order: Kenneth Oxtoby called the meeting to order at 5:16 PM.
- 2. Approval of Minutes: Michelle Jarusiewicz moved to approve the minutes of September 15, 2020, second by Kolby Blehm, vote 5 0.
- 3. Dates to Remember: TSC meetings October 13 and October 27.
- 4. Administrator's Reports
  - 4.1 Superintendent's Report: Mr. Gradone reported the town of Truro is undertaking the legal responsibility for staff Covid 19 testing with the testing company. Mr. Gradone gave an overview of federal and state grants. The grants have been amended to give a longer period of time to expend funds. There are two grants for Covid related purposes. TCS will use a federal grant to cover the Title One gap. The approved 20 21 school calendar will be updated. Mr. Gradone reminded all TSC members of the required ethics training.
  - 4.2 Acting Assistant Superintendent-Principal Report: Mrs. Costigan reports school began with 68 in-person students in Kindergarten through grade five and 31 remote students in Kindergarten through grade five. Some remote families would like to have their children switch to in-person learning. A survey on remote learning has returned positive feedback. Overall the platforms Seesaw and Google classroom are better organized and presented. All students may have breakfast which is eaten in the classroom.
  - 4.3 Business Administrator Report: Mrs. Harper will have a comprehensive financial statement at the October 13 TSC meeting.
- 5. Visitor/Faculty Statements: Hannah King thanked the TSC for making the TSC meetings accessible to viewers at home.
