Stephanie Costigan referenced the recently negotiated Five Year Nauset Tuition agreement with the Nauset School District, with terms set for the first three years and the final two years to be revisited in year three. Tuition is to start at \$23,108 per pupil.

Stephanie Costigan reviewed adjustments to the proposed FY2025 budget including a 2% increase in the Superintendent's salary as approved by the committee last summer, a reduction in the Nauset tuition line to better reflect the projected number of students attending Nauset in grades 7-12+ and an additional \$1,000 to the Maintenance of grounds supply line to include materials for the Farm to School program. The adjusted FY2025 bottom line was reported as \$6,080,872; an increase of \$108,328 over FY24, or 1.81%. Vote to be presented at the public meeting of January 25, 2024.

6. Executive Session: There will be an executive session to discuss strategy with respect to collective bargaining.
