ITEM: Tax Classification Hearing pursuant to MGL Ch. 40 S. 56

EXPLANATION:

Every year prior to setting the tax rate, the Selectmen must conduct a classification hearing for the purpose of determining the percentages of the local tax levy for the Fiscal Year and to vote on the tax rate options available to the municipality under the property tax classification statute, MGL Chapter 40, Sec. 56. The hearing is held after the Assessors have determined final values, classified all properties and reported this information to the Department of Revenue for certification. On August 11, 2017, the Department of Revenue certified Truro's Assessed Values for Fiscal Year 2018. The Assessors herein provide the Selectmen with the information necessary to make classification decisions.

Listed below are the FY2017 & 2018 levy totals by classification from the state report LA-5, allowing a visual of potential impact on the individual class. (The 2018 levy values are currently not certified as the recap process has not yet been completed.)

1. Classifying the tax rate:

- Classifying the tax rate means applying the same or different tax rates to different classes of property (residential, open space, commercial, industrial and personal property) according to procedures and formulas set by state statutes. Truro does not

- have any property that is classified by the DOR as Open Space.
- Voting a residential factor of "1" establishes that the same tax rate is applied to all classes of property at a single rate per thousand dollars of value.
- Voting a residential factor of ".9" would reallocate the tax from the residential and Open Space (by reducing their tax rate 10%) to the Commercial, Industrial & Personal Properties classes (by increasing their tax rate 10%).
- Though the tax rates would differ according to the property class, the total tax levy remains the same.
- At their meeting held on August 14, 2017, the Board of Assessors voted unanimously to recommend to vote a residential factor of "1".

2. Open Space Discount:

- Truro does not have any properties classified (by the Department of Revenue) as
 Open Space so it would have no effect if the Board of Selectmen should vote on an open space discount.
- The Open Space properties are addressed through conservation restrictions or chapter land exemption.
- At their meeting held on August 14, 2017, the Board of Assessors voted unanimously to recommend to vote not to grant an Open Space discount.

3. Residential Exemption:

- The Residential exemption grants an exemption of up to 35% of the average residential property value for all eligible year-round resident property owners.
- Through the application procedure of the exemption to the year-round residents and the calculation of the new tax rate to recapture the exempted levy, the exemption results in reduced taxes being paid by the year-round resident property owners.
- At their meeting held on August 14, 2017, the Board of Assessors voted unanimously to recommend to vote to grant a residential exemption.

4. Small Commercial Exemption:

- This exemption would reallocate the tax within the Commercial and Industrial classes from the small Commercial and Industrial properties (under \$1million valuation & less than 10 employees) to larger Commercial and Industrial properties in Town.
- As Truro has a minimal Commercial/Industrial class, the Small Commercial exemption could cause hardship on some local businesses.
- At their meeting held on August 14, 2017, the Board of Assessors voted unanimously to recommend to vote not to grant a small business exemption which would reallocate the tax within the commercial, industrial and personal property classes from certain small commercial properties to other commercial and industrial properties.

5. LA-5 Signature:

- As part of the annual Recapitulation Report (Recap) being certified by the
 Department of Revenue, the Assessor is required to inform the Board of Selectmen
 the amount of the current year excess levy capacity. The Board's signature on the LA5 Gateway Report is required as proof of this notification at the conclusion of the
 Classification Hearing.
- To expedite this step and avoid the need for each Selectman to come to the
 Assessor's Office and individually sign onto the Department of Revenues' Gateway
 form, please vote to authorize Cathy Fryxell, Principal Assessor, authorization to sign
 the LA-5 on behalf of the Selectmen.

FINANCIAL SOURCE (IF APPLICABLE):

IMPACT IF NOT APPROVED: The Fiscal Year Tax Recapitulation Report cannot be completed and the new Tax Rate cannot be set in order to generate timely Real Estate Tax Bills.



ITEM: Approval and signing of Eversource Rate Increase Letter

EXPLANATION: Maggie Downey of Cape Light Compact prepared comments for member Towns to submit to the Department of Public Utilities (DPU) regarding the Eversource rate increases that were filed on January 17, 2017 and the subsequent filing on June 1st of revisions to their proposal. The revision proposes shifting \$30 million annually in costs from Western MA electrical customers to Eastern MA residential customers, including shifting costs from commercial customers to residential customers. This rate increase will provide Eversource an additional \$50 per year in fixed charges even if customers reduce or maintain their normal electricity usage. In addition, there will also be a new demand charge starting January 1, 2018 for net-metered customers and those that install solar/PV or other renewables which will serve as a deterrent to implementation of clean energy solutions.

The DPU has reopened the public comment period through August 31st. The Cape Light Compact is encouraging written comments opposing the shift in costs and I concur with their recommendation. IMPACT IF NOT APPROVED: Truro's voice will not be heard on increases that will have an impact on Truro residents.

RE: Eversource Rate Case (DPU 17-05) - Revised Rate Design submitted 6/1/2017

Dear Secretary Marini:

We are writing to advise you that the Board of Selectmen from the Town of Truro does not support the proposed Eversource rate increases filed on January 17th, 2017 and the proposal to further increase costs to Eastern Massachusetts residential customers that was filed June 1, 2017.

The Board specifically objects to the following elements of the Eversource Rate Case, DPU-17-05:

- 1. Shifting costs from Western Massachusetts to Eastern Massachusetts. Eversource's June 1st proposal requires residential customers in Eastern Massachusetts to subsidize Western Massachusetts customers by shifting an additional \$30 million annually to Eastern Massachusetts residential customers. Costs incurred to provide electric service to Western Massachusetts customers should be borne by those customers, and not shifted to Eastern Massachusetts customers. Saddling Eastern Massachusetts residential electric customers with an additional \$30 million in annual costs with no benefits is unfair and unduly burdensome to our residents. This is cross-subsidization and the DPU should not allow it.
- 2. Shifting costs associated with Eastern Massachusetts commercial customers to Eastern Massachusetts residential customers. Given the high percentage of residential customers and second home owners on Cape Cod and Martha's Vineyard, this will be a significant economic impact on our community. Costs incurred to provide service to commercial customers should not be borne by residential customers, and we respectfully request that the DPU reject this proposal.

- 3. Eversource's proposal to more than double the fixed customer charge for residential ratepayers. A higher fixed customer charge devalues energy efficiency because it decreases a customers' ability to lower their electric bill by using less kilowatt hours. This increased customer charge means customers will pay Eversource an additional \$50 per year in fixed charges, even if they reduce or maintain their normal electricity usage.
- 4. **Eversource's proposed high return on equity.** Eversource making a 10.5% return on equity which is higher than the national average for a regulated utility (according to MA Attorney General, national average is 9.3%) and higher than rate cases in other New England states that were approved in 2016 (9.1% in CT, 9.0% in ME). Eversource's return on equity should be consistent with the national average.
- 5. **Proposed new demand charges for renewable customers.** Eversource's proposed new demand charges for customers who install solar/PV and other renewables, and the proposed higher fixed customer charges for solar/PV starting in 2018. These new charges, coupled with the lowering of the net metering credit value for all customers, will adversely impact the state's efforts to achieve the goals of the Massachusetts Green Communities Act and the Global Warming Solutions Act.

In closing, the DPU should not allow Eversource to force Eastern Massachusetts residential ratepayers to subsidize other ratepayers, and should reject the elements of their rate case that limit customer control over their energy costs and discourage customers from producing their own clean energy.

In recognition of National Suicide Prevention Month, the Cape & Islands Suicide Prevention Coalition is once again seeking to have the week of September 10-16 2017 named "Suicide Prevention Awareness Week" in all of the Cape and Islands towns.

We aim to recognize this painful and often hidden part our communities, to demonstrate our commitment to suicide prevention, and to send a message of hope to those struggling, grieving, or affected in any way by suicide. We know that by decreasing the stigma that surrounds suicide, we increase the likelihood that someone will reach out for help.



Chair Paul Wisotzky called the meeting to order at 5:00 p.m.

TABLED ITEM

The Beach Commission discussion on a Residential Only Parking Lot at Coast Guard Beach has been tabled until September 26, 2017.

BOARD OF SELECTMEN ACTION

Cape Cod Regional Technical High School Building Project

Erin Orcutt, Business Manager for Cape Cod Regional Technical (CCT) High, made a presentation on their building project. She thanked Trudi Brazil and the Truro School Committee, explained the importance of tech skills, gave enrollment figures, outlined the history of the project so far, gave the expected next steps in 2017, explained the alternatives considered, and pinpointed the location of the new construction. Ms. Orcutt also provided regional enrollments, valuations, financial impact for Truro, debt schedules for 30 years, and the vote mechanics according to Chapter 71 Section 16 (n). She affirmed that a majority vote of the towns is needed to approve the project. She requested endorsement from Truro.

Jay Coburn moved to endorse the project and urged the voters to approve. Robert Weinstein seconded, and the motion carried 5-0.

Update on Pesticide Control Options

Assistant Town Manager Kelly Clark gave an update on options for pesticide control. KP Law said the Town had limited ability to do so because the Mass Pesticide Board has the exclusive authority to regulate pesticides in Massachusetts. Town staff has worked with Wellfleet and Provincetown to mitigate mosquito control companies. They considered sending letters to the Pesticide Board, banning foggers, and contacting Representative Sarah Peake to work on amendments. Conservation agents from the three towns worked on a regional complaint form. The Mass Pesticide Board insists on evidence with dates, time and weather. The three towns discussed issuing a joint press release, the common form, the jurisdictional issues, holding regional informational session, launching a Frequently Asked Questions on each town's website, and continuing to compile complaints. Rae Ann Palmer said that the health agents intend to bring the possibilities before the health boards of the three towns.

Janet Worthington moved to direct the Assistant Town Manager to draft a letter for review, on behalf of the Selectmen, to the Board of the Wellfleet Board of Selectmen regarding the licensing of mosquito spraying companies in their community; and/or direct the Town Manager to draft a letter, on behalf of the Board, to the Massachusetts Pesticide Board encouraging the Pesticide Board to petition for legislation that would limit the use of "foggers" as an application method to limit "chemical drift"; and/or authorize a Selectperson to contact Representative Peake and/or Senator Cyr

on behalf of the Board to ask for their support in amending the current Massachusetts Pesticide Control Act (MGL 1328) to provide more regulatory control to local communities. Robert Weinstein seconded, and the motion carried 5-0.

Skip Childs came forward and thanked the Board. He had an update on the pesticide applications that have been done on his abutter's property. He said an agent from the Department of Agriculture has taken samples for lab study from his property.

Jay Coburn moved to approve the Consent Agenda as printed. Maureen Burgess seconded, and the motion carried 5-0. Paul Wisotzky abstained from Item D.

SELECTMEN REPORTS AND TOWN MANAGER REPORT

The Selectmen made their reports. Jan Worthington said she had met with Representative Sarah Peake and the Harbor Committee about ramp fees. Representative Peake followed up with information on user fees for moorings and ramps from the Chatham Harbor Master. Maureen Burgess said four part-time residents had approached her with their concerns about a residential tax exemption. She also said that the Planning Board will beginning discussion of a town-wide house size bylaw. Finally she said she had shared an e-mail about conditions at Snow's Field. Paul Wisotzky gave a reminder about the Part-time Residents' meeting the next day. He announced that the Truro Housing Authority and Highland Affordable Housing are to receive the Community Partnership Housing Award from Habitat for Humanity on September 14, 2017. Jay Coburn said he had been receiving e-mails about the proposed residential tax exemption. He asked about applications, and Town Manager Rae Ann Palmer said that from the 800 eligible properties about 200 applications had been submitted. Robert Weinstein concurred about Representative Peake's help for the Pamet Harbor Committee. He called attention to a pipe in the channel that needs to be marked until it is removed by the dredging company. He also thanked staff, the Shellfish Advisory Committee and Shellfish Warden for their work in increasing shellfishing in Truro this year.

Bruce Boleyn came forward to recognize the excellent job Assistant Town Manager Kelly Clark had done while the Town Manager was on vacation. Town Manager Rae Ann Palmer agreed and was glad to hear the praise from others. Ms. Palmer reported on plans to remove the pipe hazard from Pamet Harbor. In September there are plans for a joint meeting with Provincetown Selectmen to review a matrix for sharing services. The Cloverleaf property deed is being prepared with attention to traffic, but a right-hand only turn is not being required. The process for planning the Affordable Housing on the site will be getting underway. Her other work has been on closing out the year. She said that the Classification Hearing will take place on August 22nd.

SELECTMEN COMMENTS

Robert Weinstein commented on the success of the Pan Mass Challenge but said he would like to have the road manager for the event meet with the Board of Selectmen to discuss their route through

Truro. Rae Ann Palmer said she is already working with staff to have a discussion with the road manager regarding use of side roads and fees to the Town since police details are needed to direct the riders and traffic.

NEXT MEETING AGENDA

Rae Ann Palmer reviewed the agenda for the August 22, 2017: the Classification Hearing, an appointment for the Local Comprehensive Plan Committee, a Suicide Prevention Week proclamation, reappointments, a letter on Eversource rate increases and review of ten Selectmen's Policies.

ADJOUNMENT

Jay Coburn moved to adjourn. Robert Weinstein seconded, and the motion carried 5-0. The meeting was adjourned at 6:06 p.m.

Truro Board of Selectmen Part Time Resident Summer Meeting Wednesday, August 9, 2017 Truro Community Center, 7 Standish Way, Truro

Chair Paul Wisotzky called the meeting to order at 5:15 p.m. He welcomed everyone and explained the purpose of the meeting: direct communication with the part-time residents. Chair Wisotzky also recommended communicating through e-mail and the Town website. There were five main topics of discussion on the meeting's agenda: Environmental Projects, Staff Introductions, Town Permitting Procedures, Bicycle Safety, and Residential Property Tax Exemptions. In addition, there was time planned for public input on these and other topics of concern.

Update on Environmental Projects

Assistant Health and Conservation Agent Emily Beebe and DPW Director Jarrod Cabral gave updates on five environmental projects. These included the Pamet River Restoration, Eagle Neck Creek and Millpond, the East Harbor culvert and salt marsh restoration, Little Pamet River assessment, and the culvert on Old County Road. Rae Ann Palmer answered a question from the audience about the computers that gather information on site.

Staff Introductions and Changes

Rae Ann Palmer introduced the staff: Assistant Town Manager Kelly Sullivan Clark; COA Director Susan Travers; Assessor Cathy Fryxell; Recreation Director Damion Clements; Town Accountant Trudi Brazil; Town Clerk/Treasurer/Tax Collector Cynthia Slade; Fire Chief Tim Collins; Library Director Tricia Ford; Harbor Master/Shellfish Warden Tony Jackett, IT Director David Wennerberg; Police Chief Craig Danziger; Sergeant Steven Raneo; Executive Assistants Nicole Tudor and Noelle Scoullar; and Custodian Jeff Falk.

Update on Changes to Town Permitting Procedures

Jarrod Cabral and Kelly Clark explained changes in obtaining permits for the Transfer Station. There is now license recognition in use at the Transfer Station. Rae Ann Palmer discussed a new option of a six-month sticker for the Transfer Station. From the audience, Rachel Carter commented negatively about the elimination of the bag fee at the Transfer Station.

Bicycle Safety

Robert Weinstein gave information on bicycle safety including a report on the recent Pan Mass Challenge. He cautioned the audience that Truro roads were not designed to handle the summer increase in traffic. He noted the designated bike lanes on Route 6.

Additional Introductions

Paul Wisotzky introduced some committee members were also present at the meeting: Bob Panessiti, Chair of the Finance Committee; Carl Brotman, Chair of the Housing Authority and Cathy Haynes, Chair of the Bike & Walkways Committee.

Residential Property Tax Exemption Presentation

Chair Wisotzky gave the background explanation of the use of a residential property tax exemption and the steps the Town has taken so far. The application deadline for an exemption is August 15, 2017. He said that a residential property tax exemption is an option allowed by Massachusetts General Law.

Rae Ann Palmer gave a PowerPoint presentation on the workings of a residential tax exemption and the possible rates. The statistics and values used were from Fiscal Year 2017, she said. There was a spreadsheet that broke down tax increases by assessed values of primary residences.

Response from the Part-time Residents

There were many questions about the residential tax exemption proposal. Micky Morin asked how to qualify as a full-time resident. Cathy Fryxell gave a number of criteria: tax return address, driver's license, car registration and excise tax, inclusion in the census list and being a registered voter. Dan Katz asked about use of tax returns. Nancy Osborne asked about the big picture. Tim Richards questioned the rationale for the whole program. Warren Green asked about projected revenue. Rae Ann Palmer said it does not add revenue; it provides relief to year-round residents of the Town. It changes the tax rate, Ms. Palmer said. Elaine Gaglio asked about the qualifying process, and Town Counsel John Giorgio reviewed Mass General Law. Susan Lichenstein asked if the non-residents would be paying more. The Town Manager said the tax rate would be set according to the exemption applications. Woody Kaplan asked about giving a break to people based on need rather than full-time residency. Christen Arroo asked about the voluntary nature of the program.

Rachel Carter was the only speaker who said she supported the effort.

There was a predominance of sentiment against the proposal. Karl Forrester said he considers it a money grab and that the option makes him feel like a second-class citizen. Kevin O'Flaherty said he actually supports redistribution of wealth but disagrees with a distinction between part-time and full-time residents for taxation.

Town Counsel John Giorgio that an examination of the Mass General Law section on exemptions reveals there are many exemptions allowed for a variety of reasons. Attorney Giorgio said the purpose of offering the exemption was to make a vibrant year-round community that actually helps the part-time residents. There are other exemptions available to Truro tax payers who are elderly, low-income and veterans. Jennie Cohen asked about other possible exemptions that would keep the community together because the proposed option was divisive. Selectman Jay Coburn commented on the problem of housing affordability for the year-round population of workers. Paul Wisotzky said the Selectmen, Affordable Housing and the Planning

Board have been working on solutions for affordable options. He said Aspen and Stowe have models for the residential tax exemption plan.

Other speakers made further observations. John Winn said the proposal was meant to have the part-time residents become full-time ones. Kevin O'Flaherty said it was passing the burden onto part-time residents. He said constitutionally the Town is not allowed to charge one group more than another. The plan is fundamentally unfair, he said, and creates an "us against them" attitude. Part-time residents want to help with solutions for affordability, he said. Dick Hirsh said he would like to see a plan that is equitable and did not consider the residential tax exemption optimal. Ann Greenbaum said she had provided the Selectmen with a list of options for providing tax relief for needy. She asked if the Selectmen would really consider what the part time residents are saying. Paul Wisotzky said her list has gone to Town Counsel.

Rae Ann Palmer said the Classification Hearing needs to be held on August 22, 2017 in order to set the tax rate for next year. John Giorgio said the Town has been examining many options. He says it's a mistake to say this is an "either or" scenario. Frank Corhaus disagreed, saying what was before them presented an "either or" situation. He mentioned a method used in Wellfleet to provide tax relief to the needy.

Speakers continued to give their perceptions. Sue Goldstone asked about having more say in how the matter is taken care of. Ed Sargent said the communication of the idea has been poor from the start, despite emails and other efforts by the Selectmen. John Marksbury, a full-time resident, said it's a mistake to go forward with the plan because of the ill will it generates. Dan Katz said he was against the plan although he had come to the meeting in favor of it, not realizing that it was based on residency. He thought it was for people who needed tax relief and suggested there were other Town expenses that could be reduced. Karen Parachio asked about attitude of full-time residents towards adding affordable housing and asked if there were any studies on how part-time residents help Truro's economy. Larry Cetrulo opposed to the plan. He asked for evidence that goal would be achieved by the policy.

Wrap-up

Rae Ann Palmer said the hearing will be held on August 22, 2017 for setting classifications and the residential rate. It then goes to the Department of Revenue, who actually sets the tax rate. David Sawicki implored the Selectmen to delay a residential tax exemption plan for a year if possible.

Paul Wisotzky closed the meeting with thanks to all for their participation.

Adjournment

The meeting was adjourned at 7:05 p.m.
