Project Description: The Project proposes lay a fifth submarine distribution cable from Falmouth

to Oak Bluffs to increase the reliability of electrical service on Martha's Vineyard. The Project includes an approximately 2.7-mile underground duct and manhole system to house the onshore 25kV distribution cable from the existing Eversource Substation off Stephens Lane in Falmouth to the landfall

site at Surf Drive Beach in Falmouth.
