**ITEM:** Finalize Annual Town Meeting Warrant

**EXPLANATION:** An article titled “Charter Amendment to Appendix B – Part 3” was identified as extraneous due to Charter changes that occurred in recent years. As this is a Select Board article and may be removed by the Select Board, staff requests that the Board remove it from the 2022 Annual Town Meeting Warrant to avoid prolonging the Town Meeting and creating confusion.

If the Board has any additional final changes to the warrant, those changes can be made by a vote of the Board at this evening’s meeting.

Staff is continuing to edit the warrant for proper grammar, spelling, enumeration, and perform other miscellaneous housekeeping edits that do not change the intent/ content of the individual articles. Insertion of the appendices, the signed Posting of the Warrant and any outstanding votes from pertinent boards and committees will be added to the warrant in the days just before it goes to the printer on April 6<sup>th</sup>.

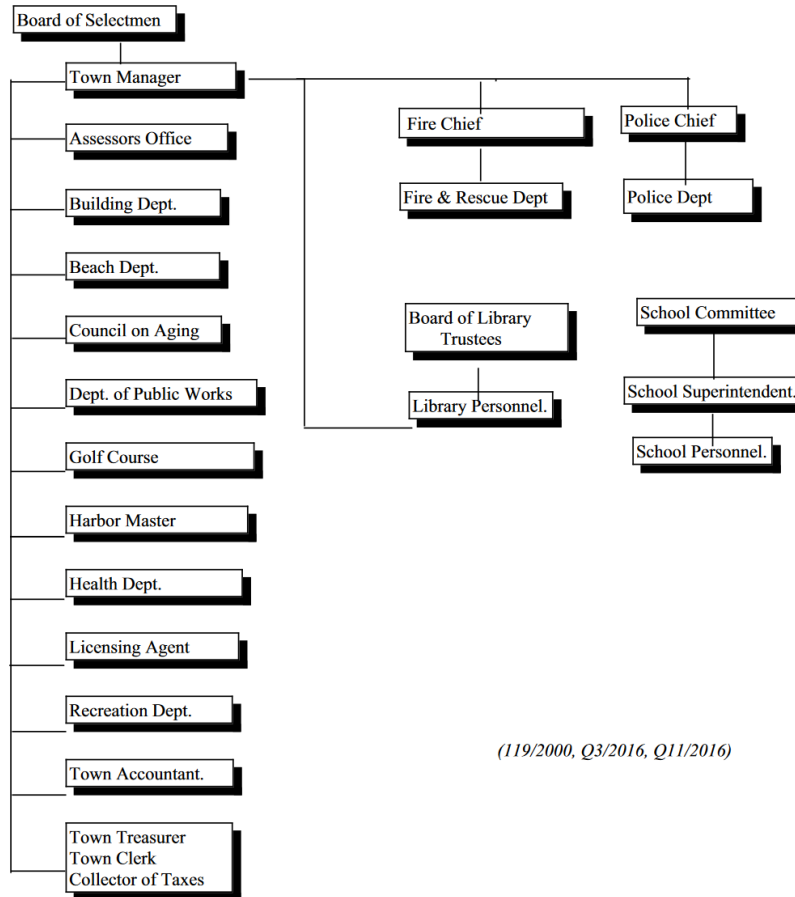

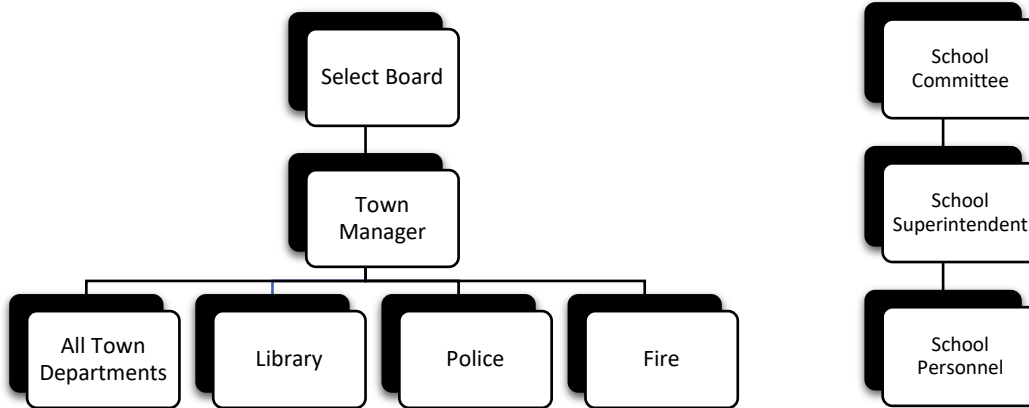
**Article 41: Charter Amendment to Appendix B – Part 3**
