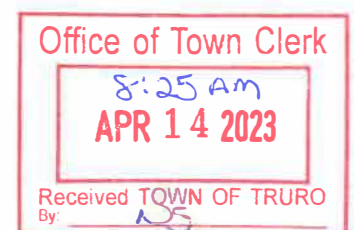

Mara Glatzel provided the Planner update:
