538 Shore Rd, Peters Property Management, Ebb Tide on the Bay, Administrative Permit-The applicant would like to plant beach grass. Motion to ratify the administrative permit by Romanelli and seconded by Messinger. The motion was approved unanimously.

544 Shore Rd, Peters Property Management, Bay Beach Town Homes, Two Administrative Permits-The applicant would like to bring in approximately 500 cu. yards of sand by use of a conveyor belt. Motion to ratify the administrative permit for sand nourishment by Messinger and seconded by Romanelli. The motion was approved unanimously. The applicant would also like to replace the decking at the

property. No heavy equipment will be used. Motion to ratify the administrative permit for deck replacement by Romanelli and seconded by Benjamin. The motion was approved unanimously.

- **5 Knowles Heights, Request for Amended Order of Conditions:** Withdrawn.
- **20 Mill Pond Rd, Notice of Intent:** The applicant requested a continuance.
- **378 Shore Rd, Stephen Goodwin, Administrative Permit:** The applicant would like to replace their beach stairs. The stairs will be built off site and then installed. Some digging will be involved where the stairs meet the sand. The Commission requested a Notice of Intent be filed and to be heard at the July 6, 2015 meeting.
- 15, 17 & 19 Avocet, 7 & 8 Kestrel Lane, 8 Falcon Lane, Enforcement Order, Greg Morris, SE# 075-828, 829, 855, 858, 859 & 860: Work was done on the beach after the allowable date of April 15. All work was to be done from the property and no machinery should have been on the beach. The work has since been completed. Motion to impose a fine of \$300.00 by Romanelli and seconded by Benjamin. The motion was approved unanimously.

Certificates of Compliance:

8 Falcon Ln, Charles and Donna Ward, SE# 75-0855: Sitec Environmental presented an alternatives analysis. It was noted that this is a continuing order with conditions to maintain after the certificate of compliance is issued.
