Well Water Testing

The Barnstable County Lab is currently open however, the courier service is suspended. All samples must be driven to Barnstable County to be analyzed. In order to limit exposure, they have closed their Lobby Receiving Area to the public. There is a cart placed in the foyer between the building's front doors and the lobby doors. Please place your sample on the cart and then press the buzzer to get the attention of the staff. The lobby door will remain closed while there is someone in the foyer. If when you arrive to drop off samples there is someone already in the foyer, please wait outside the building until they leave.
