## This week's activities of note from the Town Manager's Office:

- A Herring River Executive Council Meeting was held on Monday at which the Stakeholder's Group was identified.
- Our Emergency Preparedness Working Group comprised of Town staff met to discuss updating the Town's Comprehensive Emergency Plan and various aspects of preparedness.
- Staff from the Licensing, Health and Building departments met to identify ways to streamline and clarify the licensing process for businesses in town. Stay tuned for revised forms during the upcoming annual licensing renewal process.
- The Finance Team is closing in on the Tax Bill mailing. When setting the tax rate, we used 330 as the number of properties eligible for the residential exemption because that was the number of applications we had in house. 330 were approved by the Board of Assessors and are included in the tax commitment. Additional applications will be reviewed and approved as appropriate and be treated as abatements. This process is well defined by Massachusetts General Law.

#### Fire Department

#### Harbormaster
